Plan 1.2 – Monument Field, Land on the north side of Birmingham Road, Hagley, Land on the south-west side of Broadmarsh Farm, Wassell Grove Lane, Hagley (DY9 9JL).

Plan 1.3 – Kinver Drive Footpaths Land at Holliers Farm, Birmingham Road, Hagley.

Plan 1.4 – Upper Brake Farm, Brake Lane, Hagley (DY8 2XR), Land lying to the north of Stakenbridge Lane, Churchill, Kidderminster.
