## National News & Updates

### Special educational needs (SEN) and disabilities: guidance for school governing boards

**On 30<sup>th</sup> January, the DfE published new guidance for school governing boards in relation to SEND.**

This guidance is intended to:

- support school governing boards' understanding of their role and responsibilities in relation to children and young people with special educational needs (SEN) and disabilities
- empower governors and trustees to hold their schools to account

The guidance also includes a useful checklist for governing boards to consider.

The board is the decision-making body of the school and is accountable and responsible for what the school does. It is vital that boards play an active role in providing support and challenge, to ensure schools are providing the best support for pupils with SEN and disabilities.

School governing boards have responsibilities to children and young people with SEN and disabilities under the [Children and Families Act 2014](#) (the 2014 Act) and to disabled children and young people under the [Equality Act 2010](#).

The governing board should be taken to mean the accountable body for the school or group of schools. In local authority-maintained schools, this will be the governing body and in an academy trust this will be the trust board.

## Research The “What Works in SEND” programme new report on inclusion

The What Works in SEND programme has published a new report looking at the inclusion of children and young people with special educational needs and disabilities in schools. It explores the key factors that facilitate the inclusion of children and young people with SEND in schools, focusing in particular on understanding what local areas can do to better to support schools to become more inclusive, improving outcomes for children and young people with SEND and their families. It offers an important look at the key ingredient to facilitate meaningful inclusion. Findings encompass facilitating factors and challenges in eight areas, including values and ethos, workforce, leadership and partnership working with parents and carers.

## Guidance for arranging Alternative Provision

On 5<sup>th</sup> February, the DfE published updated guidance for arranging Alternative Provision [Arranging Alternative Provision - guide for LAs and schools](#)

This statutory guidance is for headteachers, local authorities, governing bodies and academy trusts.

It applies to all educational settings providing alternative provision (AP):

- schools maintained by the local authority
- [academies](#) and [free schools](#)
- pupil referral units (PRUs)
- further education colleges
- independent providers that deliver alternative provision

This guidance covers the use of AP where:

- local authorities arrange education for pupils who, because of exclusion, illness or other reasons, would not otherwise receive suitable education
- schools arrange education for pupils on a fixed-period exclusion
- schools arrange education for pupils to improve their behaviour off-site

Statutory guidance sets out what schools and local authorities must do to comply with the law.

## Local News & Updates

### 'Deep dive' feedback – update about our SEND improvement journey

The Department for Education and NHS England held a 'Deep Dive' meeting with the SEND local area partnership in December. This is part of standard process to monitor the progress we've been making on our Priority Action Plan.

The key areas of progress they recognised are:

- Additional support offers have been put in place to effectively manage waiting lists for the Umbrella Pathway. This includes recruiting three nurses for triage and support, to improve patient flow and reduce waiting times.
- 250 young people aged 16 and over have been given the option to transfer from the Umbrella Pathway to private providers for their autism assessment.
- The recruitment of a Co-production Co-ordinator, alongside an Emotional Mental Health role will strengthen the work of co-production across the partnership.
- The Youth Cabinet has demonstrated high levels of engagement, and their manifesto prioritised mental health and SEND. They aim to build a strong relationship with the SEND Co-production Co-ordinator and continue linking with the SEND and AP partnership committee.

### New Independent Chair of the SEND and Alternative Provision Executive Board

We are delighted to announce the appointment to the role of Independent Chair of the SEND and Alternative Provision Executive Board, Jane Friswell. Jane has worked across England with Local Authorities, Area Partnerships, Multi Academy Trusts, NHSE, Local Health Care Trusts and Social Care bodies. Jane describes herself as a SEND agent of change, delivering tangible and sustainable difference to improve outcomes for children, young people and their families. Jane has an excellent understanding and application of effective, strategy, policy and practice in special educational needs and disabilities and whole school improvement. As a parent of a young man with autism and additional learning needs, Jane provides a blended perspective as a leader for SEND with strong purpose and support for parent carer advocacy. Jane will be in post once the HR processes are complete.

## Change Programme update

At the Headteacher Briefing on 11<sup>th</sup> February, WCC leaders provided an update on the work of the Change Programme. In Phase 2, the DFE have refined the focus of the programme to two specific areas:

- Inclusive Provision
- Testing a model for Three-Tier Alternative Provision

### Inclusive Provision

We shared the journey of the development of the co-produced 'Ordinarily Available Inclusive Provision' document and ask that SENCOs review this document in its existing form and provide feedback to by the end of February.

We also launched our Collaboration with the University of Worcester, who are delivering a Changemakers Leadership Programme to support the roll out and test of refining and embedding IP in a sample of settings across Worcestershire. It is our aim that all Districts and Phases are represented within this test group.

## “Support While You Wait” - information for patients/service users who are awaiting an appointment with Children’s Health Services

A new website “Support Whilst You Wait” has been created to support children and young people, as well as their families, who find themselves experiencing long waits for appointments with health services in Worcestershire.

These include appointments for Community Paediatrics, Umbrella Pathway, Occupational Therapy, Physiotherapy and CAMHS.

The website, created by Herefordshire and Worcestershire Integrate Care System (ICB), contains details of resources and support available locally and nationally. This includes links to web resources, telephone advice and some in-person groups.

Worcestershire’s Children’s Community Health services are continuing to experience a high volume of referrals and unfortunately that means children and young people are waiting longer than usual for their first appointment. This can be worrying and frustrating and the ICB are working as a system to improve waiting times for children, young people and their families.

Feedback received from SENCOs about the blended approach of virtual and face-to-face SENCO network events has been overwhelmingly positive. SENCOs also fed back that information received from a range of partners provided them with updated information about services, guidance and met training needs which enabled them to feel confident in carrying out their role.

## Deferred and Delayed Entry Guide 2025

Parents and carers in Worcestershire now have access to a comprehensive new guide to help them make informed decisions about deferred and delayed entry to schools.

The Deferred and Delayed Entry Guide 2025 provides clear and practical information about the processes, criteria, and support available for parents who may be exploring whether deferred or delayed school entry is the right choice for their child. It aims to clarify complex procedures and offer reassurance to families during this important decision-making process.

Children are not of compulsory school age until the term following their fifth birthday. Parents can defer the date their child is admitted to school until later in the same school year following their fourth birthday, providing they do not defer beyond the point at which they reach compulsory school age, or beyond the start of the final term of that school year.

Parents must apply for a school place in the normal way at the usual time. At the point that a parent has been offered a school place, they should liaise directly with the school to notify the school that their child's entry to a reception class will be deferred until later in the same reception academic year group, when they reach statutory school age. This cannot be beyond the point at which they reach compulsory school age, or beyond the start of the final term of that school year.

## Flexi-Schooling Guidance

Flexi-Schooling is an arrangement between parent and school where children of compulsory school age are on roll at a school but where the provision is split between attendance at school and home education arranged by the parents or carers. ## Empowering Autistic Young People

The National Autistic Society (NAS) have created a collection of free resources designed to **help autistic teenagers better understand their unique experiences**. The **'Know Yourself'** collection aims to give teens the knowledge and confidence to navigate their self-discovery journey.

Resources include videos, PDFs, worksheets and downloadable guides, to support autistic teenagers in understanding what being autistic means to them.

On 22 January 2024, nasen published an updated version of the SEND Teacher Handbook which is available for free download. This handbook has been developed as a resource for teachers to use over time as they embed inclusive practice in their classrooms: it is not intended that it is read cover-to-cover. It has been written for both primary, secondary and specialist colleagues: teaching assistants, teachers, senior leaders and headteachers. The handbook includes whole-school and whole-class approaches as well as subject-specific and condition-specific guidance.

It brings together practical examples of high-quality teaching - placing focus on removing barriers to learning, getting to know and understand individual learners, and bringing to life the graduated approach. With three completely new subject-specific chapters for History, Geography and Religious Education, it offers a wealth of ideas and information about the following key areas:

- Planning inclusive lessons
- Creating including environments
- Curriculum considerations for KS3 and 4
- Strategies to scaffold learning
- Vocabulary retentions
- Supporting learners who need additional conceptual understanding
