Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984



Description of the map

The map shows the Prohibition of Waiting zone on B4082 Main Road/Checketts Close, **Pinvin:**

Checketts Close (both sides): From its junction with B4082 Main Street for 15 metres in an easterly direction.

B4082 Main Street: From its junction with Checketts Close for 10 metres in a northerly direction and for 10 metres in a southerly direction.
