Description of the map

The map shows the **Limited Waiting (1 hr no return 2 hrs Mon-Fri 8.30am – 5pm)** on Henwick Road, Worcester:

Henwick Road (West side) from a point 36 metres southeast of its junction with Wheeler Close for a distance of 39 metres in a south easterly direction.
