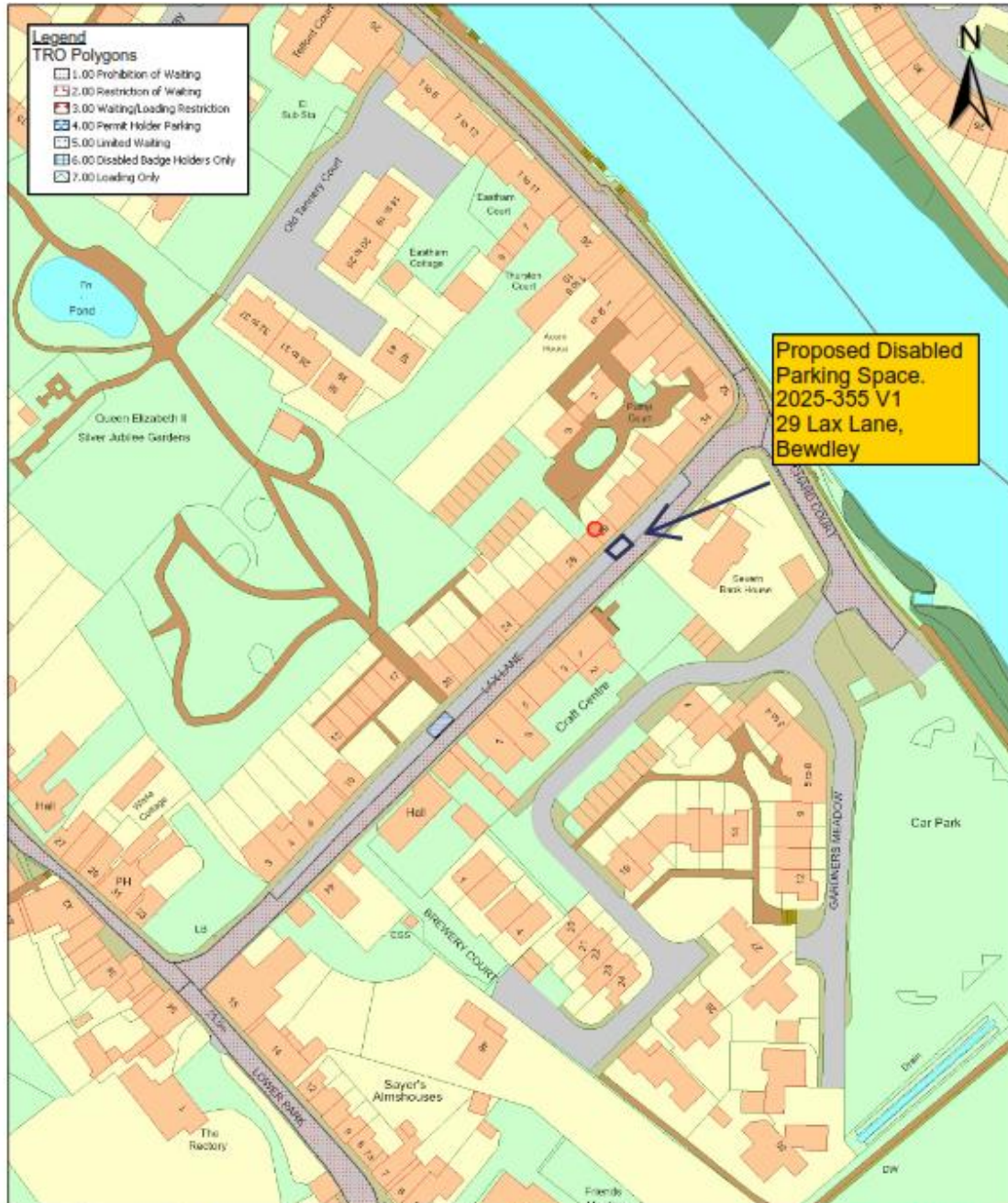
Map and plan of the area

The map shows the **Disabled Persons' Parking Space** on Lax Lane, **Bewdley**:

Lax Lane (west side): from a point of 39 metres from its junction with Pritchard Court for a distance of 6.6 metres in a south westerly direction.
