

Map of Radford Avenue, Kidderminster and the **disabled persons' parking space** implemented by the above order.

Description of the map

The map shows the **disabled persons' parking space** on Radford Avenue, Kidderminster:

Radford Avenue (south west side) from a point 16.4 metres north west of its junction with Baxter Avenue for a distance of 6.6 metres in a north western direction.
