## Map and plan of the area

Map of Regents Park Road and Medici Road, Bromsgrove and the **prohibition of waiting** zone implemented by the above order.

### Description of the map

The map shows the **prohibition of waiting zone** on Regents Park Road and Medici Road, **Bromsgrove**:

**Regents Park Road (South sided):** From a point 20m east of its junction with Green Park Road, for a distance of 139m in an easterly direction.

**(North side):** From a point 24m east of its junction with Abbey Close, for a distance of 83m in an easterly direction.

**Medici Road (East side):** From its junction with Regents Park Road, for a distance of 10m in a northerly direction.

**(West side):** From its junction with Regents Park Road, for a distance of 10m in a northerly direction.
